## S.M. WEST SENIOR OPEN LUNCH STUDENT EXPECTATIONS

- I (the student) am aware that in order to leave campus for lunch, I must have my ID card in my possession and be prepared to present it to a teacher, police officer or school administrator when leaving or entering the building, campus, or upon request. I am also aware that it is my responsibility to obtain the Open Lunch sticker for my ID Card. Open lunch privileges are only valid with the student's ID card and a valid Open Lunch sticker affixed to the ID card. The Senior Open Lunch privilege is only allowed during my scheduled lunch period.
- I am aware that if I lose my open lunch I.D. card for any reason, a replacement card will cost \$5.00.
- ♦ I am aware that Senior Open Lunch students must exit and enter the main entrance doors by the office (Entrance #1) only and must park in the 85<sup>th</sup> street student lot (with a valid parking permit).
- I am aware that the lunch period is approximately (30) thirty minutes in total length. Two (5) five minute passing periods are included in this (30) thirty minutes.
- I am aware that car trouble, running out of gas, keys being locked in the car, not finding a place to park, etc., may result in an unexcused absence or tardy from class and possible suspension or revocation of the open lunch privilege.
- ♦ I am aware that **outside commercial food and drinks/bottles may not be brought inside the building.**
- I am aware that students (including siblings & relatives) without permission are **NOT** permitted to leave campus for lunch and the driver and/or owner of the vehicle transporting such students may result in the open lunch privilege and parking permit being suspended or revoked.
- I am aware that Senior Open Lunch may be closed due to bad weather, hazardous road conditions, and security concerns or for any other reason considered appropriate by the school administration.
- I am aware that the school administration has the right to rescind or deny Senior Open Lunch permission at any time for any reason.
- I am aware that I must be a student in "good-standing" to maintain the Senior Open Lunch privilege which means no major discipline issues, unexcused absences, chronic tardiness (especially to class after lunch) and violations of the open lunch expectations. If I become a student that is no longer in good-standing, the open lunch privilege may be suspended for a period of time or permanently revoked at the discretion of the school administration.
